Notice Concerning Status of Acquisition of Own Shares and Completion of Acquisition (Acquisition of Company's own share according to the articles of incorporation pursuant to Article 165, Paragraph 2 of the Companies Act of Japan)

NISSIN FOODS HOLDINGS CO., LTD. (hereinafter "the Company") has acquired its own shares in accordance with the provisions of Article 156 of the Companies Act of Japan as modified by the provision of Article 165, Paragraph 3 of the same Act, as follows.

The Company also announces that it has completed the acquisition of its own shares based on the resolution of the meeting of the Board of Directors held on May 8, 2025.

- 1. Acquisition period: From August 1, 2025 to August 4, 2025
- 2. Type of shares acquired: Common stock of the Company

Total number of shares acquired: 306, 300 shares

Total amount of acquisition price of shares: 880, 610, 400 yen
