Notice for Price Revision: Effective June 1, 2019 shipment

NISSIN FOOD PRODUCTS CO., LTD. (President: Noritaka Ando: hereinafter “the Company”) will revise the prices of its bag-type instant noodle products, cup-type instant noodle products, and cup-type instant rice products effective from June 1, 2019 shipment.

The prices of ingredients and packaging materials for products have been increasing than the Company’s expectation. In addition, the hike in labor cost and logistics cost has brought the environment to a challenging stage. Under such circumstances, the Company has sought to reduce the costs and maintain the line of the prices of its products. However, the situation has come to the point where the Company is no longer able to entirely absorb the increasing costs.

Therefore, the Company were left with no choice but to revise the prices of the products effective from June 1, 2019 shipment to provide “safe and secure” and high-quality products for the consumers.

The Company will continue to improve business efficiency, and to propose attractive products to consumers, harnessing the technological capabilities that the Company has developed over many years.
